Item 7.01 Regulation FD Disclosure

Voya Financial, Inc. (the “Company”) is furnishing this Current Report on Form 8-K to disclose the assets under management (“AUM”) of its Investment Management (“IM”) segment prior to the availability of the Company’s quarterly earnings release and quarterly financial supplement for the quarter ended September 30, 2018, scheduled for release on October 30, 2018.

As of September 30, 2018, AUM of the Company’s IM segment was \$210 billion. AUM as of September 30, 2018 included \$89 billion of IM-sourced external client assets, \$38 billion of affiliate-sourced external client assets, \$27 billion of variable annuity-sourced external client assets and \$56 billion of Company general account assets. External client assets are reported on a market value basis. General account assets are reported on a statutory book value billing basis consistent with revenues earned. On a market value basis, general account assets were \$58 billion as of September 30, 2018.
