(1) On August 7, 2014, the Reporting Person received a grant of restricted stock units ("RSUs") covering 9,150 shares of KLA-Tencor common stock. On August 7, 2015, the Reporting Person vested in twenty-five percent (25%) of such RSUs.

(2) Pursuant to such terms of the August 7, 2014 RSU grant, 860 shares of KLA-Tencor common stock were automatically withheld at vesting to cover required tax withholding.
