ITEM 2. Acquisitions or Disposition of Assets

On April 1, 2004, WesBanco, Inc. and Western Ohio Financial Corporation jointly entered into a definitive Agreement and Plan of Merger. Under the terms of the agreement, WesBanco will exchange a combination of its common stock and cash for Western Ohio common stock. Western Ohio will be able to elect a fixed exchange ratio of 1.18 shares of WesBanco common stock or \$35.00 in cash.
