This Amendment No. 21, amends the Schedule 13D filed on January 5, 1998, as amended, and is filed by General Electric Capital Corporation ("GE Capital"), for and on behalf of itself, General Electric Capital Services, Inc. ("GECS") and General Electric Company ("GE") (collectively, the "Reporting Persons"), with respect to the common stock, par value \$0.01 per share ("Common Stock"), of Media Services Group, Inc., formerly known as MKTG Services, Inc. (the "Company").

ITEM 5. INTEREST IN SECURITIES OF THE ISSUER.

(a) The responses of the Reporting Persons to Rows (11) through (13) of the cover pages of this Amendment No. 21 are incorporated herein by reference.

As of July 20, 2004, GE Capital beneficially owned in the aggregate 61,312 shares of Common Stock representing approximately 4.7% of the outstanding shares of Common Stock (such outstanding shares being determined in accordance with Rule 13d-3(d)(1) under the Exchange Act to equal the number of shares outstanding as of May 14, 2004 (i.e., 1,296,262 shares), as reported in the Company's Quarterly Report on Form 10-Q for the quarterly period ended March 31, 2004.

Except as disclosed in this Item 5(a), none of the Reporting Persons, nor, to the best of their knowledge, any of their executive officers and directors, beneficially owns any shares of Common Stock of the Company.

(b) The responses of the Reporting Persons to (i) Rows (7) through (10) of the cover pages of this Amendment No. 21 and (ii) Item 5(a) hereof are incorporated herein by reference.

Except as disclosed in this Item 5(b), none of the Reporting Persons, nor, to the best of their knowledge, any of their executive officers or directors presently has the power to vote or to direct the vote or to dispose of or direct the disposition of any of the shares of Common Stock which they may be deemed to beneficially own.

(c) On July 20, 2004, GE Capital sold an aggregate of 8,400 shares of Common Stock for an average sales price of \$8.011 per share pursuant to Rule 144 under the Securities Act of 1934, as amended, on the Nasdaq small cap.

(e) GE Capital ceased to be the beneficial owner of more than five percent of the Common Stock on July 20, 2004.
