On October 28, 2016, the issuer declared a cash dividend of \$0.12 per share of common stock, payable December 23, 2016 to all shareholders of record on December 9, 2016 (the "Dividend"). In accordance with the terms of the Restricted Stock Agreements dated January 2, 2013, January 2, 2014, August 25, 2014, January 2, 2015 and January 4, 2016, 173, 76, 99, 255 and 315 additional shares of restricted stock were received by the reporting person in connection with the Dividend, respectively. The additional shares of restricted stock will vest as follows: 173 shares in even increments over 2 years beginning January 2, 2017, 76 shares in even increments over 3 years beginning January 2, 2017, 99 shares in even increments over 3 years beginning August 25, 2017, 255 shares in even increments over 4 years beginning January 2, 2017 and 315 shares in even increments over 5 years beginning January 4, 2017.
