**Sales for fiscal 2006 were up approximately \$5 million compared to fiscal 2005. Despite the increase in sales, the pretax loss for fiscal 2006 was approximately \$7.1 million (unaudited). The major contributors to this loss were lower sales to Sears (\$5.8 million less than fiscal 2005), the Evans Rule Division's largest customer, and increases in medical and pension costs of \$1.3 million and \$1.8 million, respectively.**
