  - (1) Represents a grant of a restricted stock award. The restricted stock award is also subject to accelerated vesting upon certain events.
  - (2) Represents the portion of a performance-based restricted stock unit (the "PRSUs") award made on July 17, 2017 that was determined to be earned based on performance for the period ending December 31, 2017. The PRSUs will vest as follows: 50% on December 31, 2018 and 50% on December 31, 2019, subject to continued service through each such date and are subject to accelerated vesting upon certain events. Each PRSU represents a contingent right to receive one share of TNET common stock upon vesting.
