Section 1 Registrant's Business and Operations

Item 1.01 Entry into a Material Definitive Agreement.

On December 28, 2012, TF Financial Corporation (the "Company"), the parent company of 3rd Fed Bank, entered into an Agreement and Plan of Merger (the "Merger Agreement") with Roebbling Financial Corp, Inc. ("Roebbling"), the parent company of Roebbling Bank, under which the Company will acquire Roebbling for approximately \$14.5 million in stock and cash.

Under the Merger Agreement, Roebbling will merge with and into the Company (the "Merger") after which Roebbling Bank will merge with and into 3rd Fed Bank. Each outstanding share of Roebbling common stock will be converted into the right to receive \$8.60 per share or 0.3640 shares of the Company's common stock, at the election of Roebbling shareholders, subject to proration. The aggregate cash consideration to be paid pursuant to the Merger Agreement must not exceed 50% of the total merger consideration (including any cash paid in connection with the Roebbling options and any shares held by the employee stock ownership plan and not allocated to participant accounts). Cash will be paid in lieu of fractional shares at a value based on the average closing sale price of the Company's common stock for the twenty trading days immediately prior to the closing date.

All Roebbling stock options, whether or not vested, will be canceled at the effective time of the Merger in exchange for a cash payment equal to the positive difference (if any) between \$8.60 and the exercise price of the stock option. In the event of a greater than 15% decline in market value of the Company's common stock immediately prior to the announcement of the Merger, which percentage decline exceeds any decline in the NASDAQ Bank Index from its starting point by more than 15%, Roebbling may be able to terminate the Merger Agreement unless the Company increases the number of shares into which Roebbling common stock may be converted.

The Merger is intended to qualify as a tax-free reorganization for federal income tax purposes. As a result, the shares of Roebbling exchanged for the Company's shares will be transferred on a tax-free basis. The Merger is expected to close during the second or third quarter of 2013. If the Merger is not consummated under certain circumstances, Roebbling has agreed to pay the Company a termination fee of \$650,000.

The Merger Agreement provides for an increase in the size of the board of directors of 3rd Fed Bank by one member. John J. Ferry, Roebbling's Board Chairman will join the board of 3rd Fed Bank. Directors and executive officers of Roebbling were also required to enter into voting agreements concurrent with the execution of the Merger Agreement (collectively, the "Support Agreements," each a "Support Agreement"). A form of Support Agreement is attached hereto as Exhibit 2.2. The Support Agreements provide that each director or executive officer of Roebbling will vote his or her shares (other than shares held in a fiduciary capacity) in favor of approval of the Merger Agreement.

The Merger Agreement contains usual and customary representations and warranties that the Company and Roebbling made to each other as of specific dates. The assertions embodied in those

representations and warranties were made solely for purposes of the contract between the Company and Roebing, and may be subject to important qualifications and limitations agreed to by the parties in connection with negotiating its terms. Moreover, the representations and warranties are subject to a contractual standard of materiality that may be different from what may be viewed as material to shareholders, and the representations and warranties may have been used to allocate risk between the Company and Roebing rather than establishing matters as facts.

The Merger Agreement also contains certain customary closing conditions, including approval by Roebing's shareholders and applicable banking regulatory authorities. As a further condition to the consummation of the Merger, Roebing's adjusted shareholders' equity (as such term is defined in the Merger Agreement) must not be less than \$15,250,000 as of the effective time. It is also a condition of the Company's obligation to close the Merger that Roebing's total non-performing assets (defined as non-accrual loans, accruing troubled debt restructurings (with certain exceptions), loans past due 90 days or more and still accruing and other real estate owned) must not exceed \$3,750,000 as of the last day of the month prior to the month in which the effective time of the Merger is expected to occur and net loan charge-offs during the period from the date of the Merger Agreement to the effective time must not exceed \$1,000,000.

The foregoing summary of the Merger Agreement and Support Agreements is qualified in its entirety by reference to the complete text of such documents, which are filed as Exhibits 2.1 and Exhibit 2.2 (form of) to this Current Report on Form 8-K and which are incorporated herein by reference in their entirety.
