**PRESS RELEASE**

*Roma, 12 August 2003* - Telecom Italia is surprised and in disagreement with the content of today's press release issued by Moody's. Not only does the analysis of the rating agency contain errors (e.g. the summing of the debt of New Telecom Italia with the one of Olimpia, a shareholder whose stake totals only 11.5%), it also fails to take any account whatsoever of the success of the management teams of Olivetti and Telecom Italia in completing a complex merger, and ignores the considerable headway made in reducing the net debt of the Group. In the judgment of other rating agencies and the market itself, the merger transaction announced on 12 March strengthened the Olivetti-Telecom Italia Group creating a solid new entity with an improved financial structure. Telecom Italia therefore intends to underline that stakeholders are not exposed to any additional risk. On the contrary, the current structure of the Group gives them solid grounds for increased confidence in the value of their investment. The Telecom Italia Group is therefore highly critical of Moody's assessment, which is believed to be inappropriate, mistaken and inaccurate, as well as without legal foundation. In line with its sense of responsibility towards the market, Telecom Italia has issued this statement with a view, among other things, to avoiding any disturbance in, or unjustified impact on, the normal trading of its shares.

- the ability of the Telecom Italia Group to achieve cost-reduction targets in the time frame established or to continue the process of rationalizing its non-core assets;
- the impact of regulatory decisions and changes in the regulatory environment;
- the impact of the slowdown in Latin American economies and the slow recovery of economies generally on the international business of the Telecom Italia Group focused on Latin America and on its foreign investments and capital expenditures;
- the continuing impact of rapid changes in technologies;
- the impact of political and economic developments in Italy and other countries in which the Telecom Italia Group operates;
- the impact of fluctuations in currency exchange and interest rates;
- Telecom Italia's ability to continue the implementation of its 2002-2004 Industrial Plan, including the rationalization of its corporate structure and the disposition of Telecom Italia's interests in various companies;
- the ability of the Telecom Italia Group to successfully achieve its debt reduction targets;
- Telecom Italia's ability to successfully roll out its UMTS networks and services and to realize the benefits of its investment in UMTS licenses and

related capital expenditures;

- Telecom Italia's ability to successfully implement its internet strategy;

- the impact of litigation or decreased mobile communications usage arising from actual or perceived health risks or other problems relating to mobile handsets or transmission masts.
