Donald Sussman (Mr. Sussman), MAK Capital One L.L.C., a Delaware limited liability company (MAK Capital), MAK Capital Fund LP, a Bermuda limited partnership (MAK Fund), and Michael A. Kaufman (Mr. Kaufman).

The Reporting Persons collectively beneficially own 2,240,696 shares of Common Stock.
