This statement is filed with respect to the shares of common stock, \$.001 par value (the "Common Stock") of Destiny Media Technologies Inc. ("Issuer") beneficially owned by the Reporting Persons identified below as of February 10, 2011 and amends and supplements the Schedule 13G filed on August 10, 2007, as previously amended (collectively, the "Schedule 13G"). Except as set forth herein, the Schedule 13G is unmodified.

The names of the persons filing this statement on Schedule 13G are (collectively, the "Reporting Persons"):

- Sabre Value Fund LP (the "Fund").
- Sabre Value Advisors LLC ("Sabre Advisors").
- Aaron Edelheit ("Mr. Edelheit").

ITEM 4. OWNERSHIP.

Provide the following information regarding the aggregate number and percentage of the class of securities of the issuer identified in Item 1.

(a) Amount beneficially owned:

The Fund beneficially owns 2,928,200 shares of Common Stock.

Sabre Advisors, as the managing general partner of the Fund, is deemed to beneficially own the 2,928,200 shares of Common Stock owned by the Fund.

Mr. Edelheit, as the managing member of Sabre Advisors, is deemed to beneficially own the 2,928,200 shares of Common Stock owned by the Fund and an additional 49,500 shares of Common Stock that he owns personally, for a total of 2,977,700 shares of Common Stock.

Collectively, the Reporting Persons beneficially own the 2,977,700 shares of Common Stock held by the Fund.

(b) Percent of Class:

Each of the Fund's and Sabre Advisors' beneficial ownership of 2,928,200 shares of Common Stock represents 5.8% of all of the outstanding shares of Common Stock.

Mr. Edelheit's beneficial ownership of 2,977,700 shares of Common Stock represents 5.9% of all of the outstanding shares of Common Stock.

Collectively, the Reporting Persons' beneficial ownership of 2,977,700 shares of Common Stock represents 5.9% of all of the outstanding shares of Common Stock.

(c) Number of shares as to which such person has:

(i) Sole power to vote or to direct the vote

Mr. Edelmet has sole power to vote or to direct the vote of the 49,500 shares of Common Stock that he owns personally.

(ii) Shared power to vote or to direct the vote of shares of Common Stock:

The Fund, Sabre Advisors and Mr. Edelmet have shared power to vote or direct the vote of the 2,928,200 shares of Common Stock held by the Fund.

(iii) Sole power to dispose or to direct the disposition of shares of Common Stock:

Mr. Edelmet has sole power to dispose or to direct the disposition of the 49,500 shares of Common Stock that he owns personally.

(iv) Shared power to dispose or to direct the disposition of shares of Common Stock:

The Fund, Sabre Advisors and Mr. Edelmet have shared power to dispose or direct the disposition of the 2,928,200 shares of Common Stock beneficially held by Onshore Fund.
