(b) On December 1, 2006, Daniel R. Henry, president and chief operating officer of Euronet Worldwide, Inc. (the Company), notified the Company of his decision to resign as president and chief operating officer of the Company, effective December 31, 2006. Mr. Henry informed the Company that he intends to continue as a member of the Board of Directors of the Company for at least the remainder of his three-year term ending at the annual meeting of stockholders in 2009.
