Explanation of Responses:

1. Represents the value of the Reporting Person's Company Stock Fund Account in the Company's 401(k) plan as of September 30, 2001, expressed as share equivalents. As of such date, approximately 95.809% of the Company Stock Fund was invested in Company Common Stock, and the remainder was invested in cash.
2. Represents shares of restricted stock granted to the Reporting Person on October 23, 1997 and April 22, 1998 under the Issuer's Long-Term Stock Incentive Plan as follows: (i) 9,828 shares which may vest on October 8, 2001, (ii) 8,299 shares which may vest over a five-year period, and (iii) 29,871 shares which may be earned for the five-year performance period ending December 31, 2001 subject to the achievement of performance goals, 50% of which may be distributed when earned and 50% of which may be distributed over a five-year period commencing on the date earned.
3. Represents shares directly owned by the Reporting Person's son, which were previously reported as 12 shares. The Reporting Person disclaims beneficial ownership.
4. Represents amounts allocated to, and the total holdings in, the Reporting Person's Company Stock Fund Account in the Company's Supplemental Savings and Investment Plan as of Sept. 30, 2001, expressed as share equivalents. Because the trustee and record keeper for this plan utilize unit accounting for the Company Stock Fund rather than share accounting, these amounts represent share equivalents allocated to the Reporting Person's account
