Item 1. Security and Issuer.

This schedule related to the common stock and warrants of Targeted Genetics Corp. (the ?Issuer?). The Issuer?s principal executive officers are located at 1100 Olive Way, Suite 100, Seattle, Washington 98101.

Item 2. Identity and Background.

The persons filing this report are Austin W. Marxe (?Marxe?) and David M. Greenhouse (?Greenhouse?), who are the controlling principals of AWM Investment Company, Inc. (?AWM?), the general partner of MGP Advisers Limited Partnership (?MGP?). MGP is the general partner of Special Situations Fund III QP, L.P. (?SSFQP?). Marxe and Greenhouse are also members of LS Advisers, L.L.C. (?LS?), the general partner of Special Situations Life Sciences Fund, L.P. (?LIFE?). AWM is the investment adviser to SSFQP and LIFE. (SSFQP and LIFE will hereafter be referred to as, the ?Funds?).

The principal office and business address of the Reporting Persons, is 527 Madison Avenue, Suite 2600, New York NY 10022.

The principal business of each Fund is to invest in equity and equity-related securities and other securities of any kind or nature.

Mr. Marxe and Mr. Greenhouse have never been convicted in any

criminal proceeding (excluding traffic violations or similar misdemeanors), nor have either of them been a party to any civil proceeding commenced before a judicial or administrative body of competent jurisdiction as a result of which he was or is now subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws. Mr. Marxe and Mr. Greenhouse are citizens of the United States.

Item 3. Source and Amount of Funds or Other Consideration.

Each Fund utilized its own available net assets to purchase the securities referred to in this Schedule.

Item 4. Purpose of Transaction.

The securities referred to in this Schedule have been acquired by each of the Funds for investment purposes and not with the purpose or effect of changing or influencing control of the Issuer. Each Fund acquired the securities in the ordinary course of business and is holding the securities for the benefit of its investors.

Item 5. Interest in Securities of the Issuer.

SSFQP owns 1,970,052 shares of Common Stock and 2,153,802 Warrants to purchase Common Stock, or 18.8% of the shares outstanding and LIFE owns 654,045 shares of Common Stock and 785,295 Warrants to purchase Common Stock, or 7.0% of the shares outstanding. Messrs. Marxe and Greenhouse share the power to vote and to direct the vote and to dispose and direct the disposition of all shares of Common Stock owned by each of the Funds. Messrs. Marxe and Greenhouse are deemed to beneficially own a total of 2,624,097 shares of Common Stock and 2,939,097 Warrants to purchase Common Stock or 24.5% of the outstanding shares.
