(1) 680 shares are held in the name of the undersigned's broker.

(2) Grant of 1.804 phantom shares of common stock ("dividend equivalents") based on phantom shares deferred under the Executive Deferred Savings Plan II in transactions exempt under Rule 16b-3. As of 06/15/05, 288.804 total phantom shares deferred, which includes dividend equivalents earned in phantom restricted stock.

(3) 839 phantom stock shares (Strategic Excellence Program) awarded on 02/14/05 under the 2002 Whirlpool Corporation Omnibus Stock and Incentive Plan in transactions exempt under Rule 16(b)-3(c). Time restrictions will lapse and shares will become vested as follows: 50% on 02/14/06; and 50% on 02/14/07.

(4) Award of 20,000 phantom stock shares (Special Retention Program) on 08/02/04 with the effective date of the award to be 09/01/04 under the Whirlpool Corporation 2002 Omnibus Stock and Incentive Plan in transactions exempt under Rule 16(b)-3(c). Shares will become vested as follows: 50% on 09/01/2007 and 50% on 02/01/2011. Participants may elect to defer receipt of vested shares. Dividend equivalents on deferred stock will be invested in additional stock.

(5) 10,000 option shares with cashless exercise and tax withholding rights awarded on 07/01/2003 at the option price of \$62.98 per share. 5,000 shares are currently exercisable, with the remaining 5,000 shares becoming exercisable on 07/01/2005. The options will expire 10 years from date of grant.

(6) 2,664 option shares with cashless exercise and tax withholding rights awarded on 02/16/04 at the option price of \$72.94 per share. 888 shares are currently exercisable, with the remaining share to become exercisable as follows: one-third on 02/16/06; and one-third on 02/16/07. The options will expire 10 years from date of grant.
