(1) Includes 3.723 shares acquired through the reinvestment of dividends on March 31, at a price of \$55.9791 per share.

(2) The number of underlying securities is based on the stock fund balance on April 5, 2005. The actual number of shares issuable upon the distribution date is not determinable since the stock fund is a unitized account consisting of 96% company stock and 4% money market fund. The stock account balance reflected in this report is based on a April 5, 2005 stock fund price of \$55.82 per share.

(4) The phantom stock units were accrued under the Johnson Controls Long-Term Performance Plan and are to be settled 100% in cash upon the reporting person's retirement.
