- (2) The number of underlying securities is based on the stock fund balance on October 2, 2012. The actual number of shares issuable upon the distribution date is not determinable since the stock fund is a unitized account consisting of 96% company stock and 4% money market fund. The stock account balance reflected in this report is based on an October 2, 2012, stock fund price of \$27.55 per share.
- (3) Fifty percent of the options vest after two years and the remaining 50% vests after three years.
- (4) Each share of phantom stock is the economic equivalent of one share of Johnson Controls common stock.
- (5) The restricted stock units accrue under the Johnson Controls Restricted Stock Plan. The balance includes phantom stock and dividend equivalent units that settle 100% in cash and relate to restricted stock awards.
- (6) Includes 920.029 phantom stock units acquired through the reinvestment of dividends on January 3, April 3, July 3 and October 2, 2012, at prices ranging from \$27.55 to \$32.60 per phantom stock unit.
- (7) The phantom stock units were accrued under the Johnson Controls Long Term Incentive Plan and are to be settled 100% in cash upon the reporting person's termination of employment with the company.
- (8) Includes 130.762 phantom stock units acquired through the reinvestment of dividends on January 3, April 3, July 3 and October 2, 2012, at prices ranging from \$27.55 to \$32.60 per phantom stock unit.
- (9) The phantom stock units were accrued under the Johnson Controls Retirement Restoration Plan and are to be settled 100% in cash upon the reporting person's termination of employment with the company.
- (10) Includes 296.217 phantom stock units acquired through the reinvestment of dividends on January 3, April 3, July 3 and October 2, 2012, at prices ranging from \$27.55 to \$32.60 per phantom stock unit.
