On April 17, 2015, the Company issued a Promissory Note for \$238,975.62 received from Sanjay Sabnani, the Company's CEO. The proceeds were used to pay off a short-term convertible note issued to KBM on October 20, 2014, as well as to provide the Company with \$25,000 in working capital. Under the terms of the Note, the Company agrees to repay the \$238,975.62 including interest at 12%. The Note, including interest, is due October 20, 2015.
