The Company expects that it will report a net loss from operations of approximately \$9.7 million in fiscal 2005, compared to a net loss from operations of approximately \$1.2 million in 2004, mainly due to increases in its expenditures for mining exploration and oil and gas property acquisition costs in 2005. The value of the Company's property holdings, consisting mainly of oil and gas and mining interests, have increased to \$13.6 million at year end 2005 from \$1.8 million 2004, and total assets at year end increased to \$19.8 million in 2005 compared to \$14.5 million in 2004.
