(1) The new grant is for 3,537 shares of common stock represented by performance-based restricted stock units, which may be adjusted up or down at the time the restrictions lapse. The restrictions may lapse based on the Company's relative cash earnings per share growth as compared to the S&P 500 GAAP EPS growth measured as of 12/31/06.

(2) The new grant is for 3,537 shares of common stock represented by time-based restricted stock units. The restrictions will lapse on 1,167 shares on each of 2/13/07 and 2/13/08, and on 1,203 shares on 2/13/09.
