## Explanation of Responses:

The new grant is for 1,263 shares of common stock represented by time-based restricted stock units. The restrictions will lapse on 416 units on 2/18/15, on 417 units on 2/18/16 and on 430 units on 2/21/17, subject to continued employment by the Reporting Person on the vesting dates.

The new grant is for 5,053 shares of common stock represented by performance-based restricted stock units, which may be adjusted up or down at the time the performance restriction lapses. The restriction may lapse with respect to 33% of such shares on each of 2/18/15 and 2/18/16 and with respect to 34% of such shares on 2/21/17 contingent on meeting an EBT metric for 2014 and subject to continued employment by the Reporting Person on the vesting dates.

The total number of securities beneficially owned includes: (a) 13,823 unrestricted shares; (b) 531 unvested units from an award of 1,560 time-based restricted stock units granted 3/21/11; (c) 3,183 unvested units from an award of 9,362 performance-based restricted stock units granted 3/21/11; (d) 1,097 unvested units from an award of 3,225 time-based restricted stock units granted 8/22/11; (e) 1,408 unvested units from an award of 2,101 time-based restricted stock units granted 2/21/12; (f) 8,450 unvested units from an award of 12,610 performance-based restricted stock units granted 2/21/12; (g) 1,808 unvested time-based restricted stock units granted 2/21/13; (h) 7,232 unvested performance-based restricted stock units granted 2/21/13; (i) the new grant for 1,263 time-based restricted stock units; and (j) the new grant for 5,053 performance-based restricted stock units.
