MTS Announces Subscriber Growth Numbers for December 2004

Moscow, Russian Federation January 10, 2005 Mobile TeleSystems OJSC (MTS - NYSE: MBT), the largest mobile phone operator in Russia and the CIS, announces that its consolidated subscriber base reached 34.2 million users on December 31, 2004.

During 2004 MTS subscriber base increased by 17.46 million subscribers. In the month of December 2004 the Company added 4.68 million customers on a net basis.
