(1) The acquisition of the Common Stock of the Issuer represents a semi-annual interest payment on the principal amount of \$1,000,000 of the Issuer's 12% Senior Secured Convertible Notes held by SkyePharma. The Issuer agreed with a majority of the holders of the Notes that effective October 15, 2004 all of the interest on the Notes commencing with the interest payment due in December 2004 would be payable at the Issuer's sole option in Common Stock of the Issuer. The June 2005 semi-annual interest payment was made at the rate of 12% per annum. The \$60,000 interest payment was converted into Common Stock of the Issuer at a price of \$0.91 per share to yield 659,341 shares of Common Stock of the Issuer.
