**MTS ANNOUNCES SUBSCRIBER GROWTH NUMBERS FOR DECEMBER 2006**

**MOSCOW, RUSSIAN FEDERATION JANUARY 17, 2007 MOBILE TELESYSTEMS OJSC ( MTS NYSE: MBT), THE LARGEST MOBILE PHONE OPERATOR IN RUSSIA AND THE CIS, ANNOUNCES THAT ITS CONSOLIDATED SUBSCRIBER BASE REACHED 72.86 MILLION USERS ON DECEMBER 31, 2006.**

During December 2006, MTS consolidated subscriber base increased by 3.18 million subscribers, of which 0.66 million were added in Russia.
