- (1) Class A common stock of the Issuer on March 9, 2007 under Rule 144 (the "Sale"). Prior to the Sale, the Fund owned less than 1% of the Class A common shares of the Issuer and after giving effect to the Sale, the Fund no longer owns any shares of common stock of the Issuer.
- Mr. Kaplan may be deemed a beneficial owner of the securities sold by the Fund by virtue of his status as a Principal of Oaktree.
