The Bank of New York, as trustee of Mesa Royalty Trust (the Trust) has been working diligently to complete all required information for its annual report on Form 10-K for the year ended December 31, 2007 (the Form 10-K), and portions of such information have been completed as of this date. However, the Trustee does not believe the Form 10-K can be completed on or before the March 17, 2008 prescribed due date due to a delay in the preparation of the Trust's fiscal year 2007 financial statements. There is a delay in the completion of reserve information by the Trust's independent reserve engineer for certain non-operated properties in which the Trust has an ownership interest. Accordingly, the trustee has not been able to complete all required reserve information required in Part I of the Form 10-K and for the footnotes to financial statements. The trustee intends to file the Form 10-K as soon as practicable, and in no event later than the fifteenth calendar day following the prescribed due date.
