Morgan Stanley Quality Municipal Securities intends to redeem the following:

11 outstanding shares of Series 1 ARPS

10 outstanding shares of Series 2 ARPS

10 outstanding shares of Series 3 ARPS

20 outstanding shares of Series 4 ARPS

13 outstanding shares of Series 5 ARPS
