Portugal Telecom, SGPS S.A. ( PT ) informs that Capital Research and Management Company now holds more than 10% of the voting rights corresponding to the share capital of PT.

Such new holding resulted from the acquisition, on 23 November 2010, on regulated market, of a total of 1,350,000 PT shares.

As a result of the above mentioned transaction, a holding of 90,421,315 ordinary shares representing 10.0859% of PT s share capital and corresponding voting rights is now attributed to Capital Research and Management Company.

PT was further informed that the shares reported in this disclosure are owned by mutual funds under the discretionary management of Capital Research and Management Company.
