- (3) On January 4, 2011, TCP 2 sold 24,500 shares of Common Stock at a weighted average price of \$10.0419 per share, at prices ranging from \$10.0416 to \$10.0454 per share. On January 5, 2011, TCP 2 sold 83,400 shares of Common Stock at a weighted average price of \$9.9662 per share, at prices ranging from \$9.660 to \$9.663 per share. On January 6, 2011, TCP 2 sold 7,100 shares of Common Stock at a price of \$9.9390 per share. The filing parties undertake to provide to the staff of the Securities and Exchange Commission, the Issuer or any security holder of the Issuer, upon request, full information regarding the number of shares purchased or sold at each separate price within the ranges described in this footnote.

- (4) Mr. Gendell and TAA directly own 0 shares of Common Stock, TP directly owns 540,790 shares of Common Stock, TCM directly owns 206,187 shares of Common Stock, TM directly owns 373,309 shares of Common Stock, TOA directly owns 641,413 shares of Common Stock, TCP 2 directly owns 7,970,994 shares of Common Stock, TPP directly owns 22,106 shares of Common Stock and TA directly owns 311,362 shares of Common Stock. On a Form 4 filed on December 15, 2010, the filing parties incorrectly reported that TCM had sold 260 shares of common stock on December 15, 2010. These 260 shares were actually sold by TCP 2. The ownership reported in this footnote reflects the correction of this error.
