**Portugal Telecom informs about news related to Dedic and Contax**

Following the news published in the press related to a potential integration between Contax Participações S.A. ( Contax ) and Dedic, Portugal Telecom, SGPS SA ( PT ) informs that it is in negotiations with CTX Participações S.A. ( CTX ), its subsidiary Contax and its controlling shareholders to define the structure and conditions of a possible corporate restructuring which would result in a potential integration of the businesses and activities of Contax and Dedic and in PT becoming a shareholder of CTX .

However, no final agreement between the parties was reached so far.
