**Issuance of Eurobond**

Portugal Telecom announces the successful issuance of a Euro 600 million Eurobond, with a maturity of 5 years, through its wholly-owned subsidiary PT International Finance BV. The coupon of this issue will be 5.625%, with a reoffer level of 295bp over the mid swap rate.

This transaction is integrated in the financing strategy of PT, which aims at having diversified maturities and sources of financing. The proceeds will be used for general corporate purposes.

Bank of America Merrill Lynch, Barclays Capital, BES Investimento, Caixa BI, Citigroup and Credit Suisse were the book-runners of this transaction.

PT has a rating of Baa2/stable by Moody's and BBB/stable by S&P.
