Issuance of Eurobond

Portugal Telecom announces that it has successfully completed the issuance of a Euro 1,000 million Eurobond with a maturity of 7 years, through its wholly-owned subsidiary PT International Finance BV. The coupon of this issue will be 4.625%.

This transaction further enhances PT's financial flexibility by extending debt maturities that, in the current environment, substantially reduces financial risks.

Bank of America Merrill Lynch, BNP Paribas, Caixa BI, Espírito Investment Bank and HSBC were the book-runners of this transaction.

PT has a rating of Ba2/negative by Moody's, BB/negative by S&P and BBB/negative by Fitch.
