**Qualified holding and long position - Morgan Stanley**

Portugal Telecom, SGPS S.A. ( PT ) hereby informs that it was notified of the following regarding a qualified holding and long position of Morgan Stanley:

**A) 2% threshold exceeded (28 November 2013)**

This change is due to Morgan Stanley & Co. International plc and Morgan Stanley & Co. LLC increasing borrowed positions by 1,862,874 and 1,062,348 PT ordinary shares respectively, on 28 November 2013. As a result, Morgan Stanley now holds a qualified holding and long position corresponding to 2.02% of PT 's share capital and corresponding voting rights. Additionally, PT was informed that this holding is as follows:

### B) Position fell below 2% threshold (29 November 2013)

This change is due to Morgan Stanley & Co. International plc and Morgan Stanley & Co. LLC decreasing borrowed positions by 592,280 and 3,280,584 PT ordinary shares respectively, on 29 November 2013. As a result, Morgan Stanley now holds a position corresponding to 1.62% of PT's share capital and corresponding voting rights.
