(1) In connection with the merger of CapitalSource Inc. with and into PacWest Bancorp on April 7, 2014 pursuant to the Agreement and Plan of Merger, dated July 22, 2013, as amended, between PacWest and CapitalSource, the reporting person received the PacWest common stock reported above, together with \$39,016 in cash, in exchange for (i) 15,796 shares of CapitalSource common stock and (ii) 49,940 restricted shares of CapitalSource, after surrendering an aggregate of 6,210 shares of PacWest common stock to satisfy tax withholdings. On April 7, 2014, the effective date of the merger, the closing price of CapitalSource's common stock was \$15.50 per share and the closing price of PacWest's common stock was \$45.83 per share.
