As previously disclosed, on January 3, 2017, South State Corporation (the <u>Company</u>) completed the merger (the <u>Merger</u>) of Southeastern Bank Financial Corporation (<u>SBF</u>C) with and into the Company, with the Company as the surviving entity in the Merger, pursuant to the Agreement and Plan of Merger, dated as of June 16, 2016 (the <u>Merger Agreement</u>), by and between SBFC and the Company. Immediately after the Merger, SBFC s wholly owned bank subsidiary, Georgia Bank & Trust Company of Augusta, merged with and into South State s wholly owned bank subsidiary, South State Bank (the <u>Bank Merger</u>), with South State Bank as the surviving entity in the Bank Merger.
