As part of a plan to right size Halcón Resources Corporation (together with its subsidiaries, the Company) corporate and administrative functions following recent asset dispositions, including the sale of its Bakken assets in September 2017, and following mutual discussions regarding the future direction of the Company, the Company has notified Joseph S. Rinando III that his last day of employment with the Company would be December 31, 2017. Mr. Rinando has served the Company with distinction as Senior Vice President, Chief Accounting Officer and Controller since December 2014, having previously served as Vice President and Chief Accounting Officer from May 2012. Upon Mr. Rinando's departure, Mark J. Mize, the Company's Executive Vice President, Chief Financial Officer and Treasurer, will be the Company's principal accounting officer. Information regarding Mr. Mize's employment arrangements with the Company, business experience and other matters is contained in the Company's definitive proxy statement filed with the U.S. Securities and Exchange Commission on March 24, 2017.
