The stock units have been deferred under the terms and provisions of the 2005 Deferred Compensation Plan for Directors of Unisys Corporation. Deferred stock units will be distributed in shares of Unisys common stock upon the earlier of termination of service or on any date at least two years after the stock units are awarded, as previously elected by the director.
- (2) Each restricted stock unit represents a contingent right to receive one share of Unisys Corporation common stock.
- (3) Time-based restricted stock units granted under the terms and provisions of the Unisys Corporation 2007 Long-Term Incentive and Equity Compensation Plan. The restricted stock units vest in three annual installments beginning February 12, 2010.
