- (1) The common shares of beneficial interest were sold in order to pay the estimated tax withholding obligation that resulted from the vesting of 500 restricted share units on March 8, 2012 and 250 restricted share units on March 14, 2012.
The reported amount consists of 2,970 restricted share units and 907 common shares of beneficial interest. The restricted share units are to be settled in an equal number of common shares of beneficial interest upon vesting. Five hundred restricted share units vested on March 8, 2012, and 250 restricted share units vested on March 14, 2012. The vested restricted share units were settled in an equal number of common shares of beneficial interest, of which 300 were sold as described in the preceding footnote and 450 are included in the reported amount.
