- (1) This amendment adds the following three footnotes that were inadvertently omitted from the original filing.

- (2) Following the transactions reported on this Form 4, Ms. Taylor continues to hold 42,884 shares directly and 1,392 shares indirectly in a 401(k) account. Ms. Taylor also holds an additional 127,419 vested stock options, 54,167 unvested stock options, and 10,026 target performance shares (the exact number awarded being dependent on achievement of performance goals).
- (3) Amount reported has been adjusted to include 79 shares of Issuer common stock acquired by the reporting person under The Prudential Employee Savings Plan between January 1, 2013 and June 30, 2013 based on a plan statement dated June 30, 2013.
