That fund holds units consisting of PG&E Corporation common stock and a small short-term investments component. These holdings have been trued up to conform to the RSP balance as of 3/3/14, and reflect the acquisition of approximately 6.88 shares on 10/15/13 and 6.87 shares on 1/15/14 due to dividend reinvestment.
