- (1) On May 16, 2012, the Issuer granted the Reporting Person a recruitment grant in the form of a Restricted Stock Award (RSA) of 16,043 restricted shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Omnibus Stock and Incentive Plan which are scheduled to vest in three equal annual installments on the first, second and third anniversaries of the date of grant, subject to continued employment of the Reporting Person by the Issuer. On May 16, 2014, 5,348 shares of the originally granted RSAs vested, of which 1,731 shares were surrendered by the Reporting Person in order to satisfy tax withholding obligations. This form is being filed to reflect the surrender of such shares to satisfy the Reporting Person's tax withholding obligation.
