- (1) On February 18, 2015 the Issuer granted the Reporting Person 11,413 Restricted Stock Units (RSU) under the First Midwest Bancorp, Inc. Omnibus Stock and Incentive Plan which were scheduled to vest in two equal annual installments on the second and third anniversary of the date of grant. Each restricted stock unit represents the right to receive one share of the Issuer's common Stock on the vesting date. On February 18, 2017, 5,707 of the originally granted restricted stock units vested, of which 2,717 shares of the Issuer's Common Stock underlying such units were withheld in order to satisfy the Reporting Person's tax withholding obligations. This form is being filed to reflect the surrender of such shares to satisfy the Reporting Person's tax withholding obligation.
- (2) On February 19, 2014 the Issuer granted the Reporting Person a Restricted Stock Award (RSA) of 9,822 restricted shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Omnibus Stock and Incentive Plan which were scheduled to vest in two equal annual installments on the second and third anniversary of the date of grant. On February 19, 2017, the remaining 4,911 shares of the originally granted RSAs vested, of which 2,245 shares were surrendered by the Reporting Person in order to satisfy tax withholding obligations. This form is being filed to reflect the surrender of such shares to satisfy the Reporting Person's tax

withholding obligation.

- (3) Between March 17, 2016 and February 21, 2017, the Reporting Person acquired 19 shares of First Midwest Bancorp, Inc. common stock under the First Midwest Bancorp, Inc. Savings and Profit Sharing Plan pursuant to the Dividend Reinvestment feature of the Plan. This information is based on a Plan statement dated January 17, 2017.
