- On February 24, 2017 the Issuer granted the Reporting Person a Restricted Stock Award (RSA) of 17,996 restricted shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Omnibus Stock and Incentive Plan which were scheduled (1) to vest in two equal annual installments on the second and third anniversary of the date of grant. On February 24, 2019, 8,998 of the originally granted RSAs vested, of which 3,987 shares were surrendered by the Reporting Person in order to satisfy tax withholding obligations. This form is being filed to reflect the surrender of such shares to satisfy the Reporting Person's tax withholding obligation.
