#### ONCOLYTICS BIOTECH ANNOUNCES \$4.1 MILLION PRIVATE PLACEMENT

CALGARY, AB, August 15, 2003 - Oncolytics Biotech Inc. (Oncolytics) (TSX:ONC, NASDAQ:ONCY) announced today that it has entered into a private placement with a European institutional investor and various Canadian investors. Subject to regulatory approval and upon completion of the transaction, Oncolytics will issue 1,363,900 common shares and 681,950 common share purchase warrants for aggregate gross proceeds of approximately \$4.1 million. Each whole common share purchase warrant will entitle the holder to acquire one common share of Oncolytics upon payment of \$4.00 per warrant. The common shares to be issued by Oncolytics will be subject to a four month hold period. The private placement is anticipated to close on August 22, 2003. Oncolytics will use the proceeds from the private placement for general corporate purposes.

#### **About Oncolytics Biotech Inc.**

Oncolytics is a Calgary-based biotechnology company focused on the development of REOLYSIN®, its proprietary formulation of the human reovirus, as a potential cancer therapeutic. Oncolytics—researchers have demonstrated that the reovirus is able to selectively kill human cancer cells *in vitro* that are derived from many types of cancer, including breast, prostate, pancreatic and brain tumours, and have also demonstrated successful cancer treatment results in a number of animal models. Phase I clinical trial results have indicated that there were no toxicology-related issues with the administration of the reovirus, and that the reovirus demonstrated activity in tumours injected with REOLYSIN®.
