Completion of Acquisition or Disposition of Assets

On May 18, 2005, the Registrant announced that it has completed the sale of one of its real estate holdings for \$170,000. The property is located in Brian Head, Utah, and was originally purchased in September of 2002 for \$68,000, returning \$102,000, or 60% return.
