As of December 31, 2006, each of Roger Feldman and Harvey Hanerfeld is the beneficial owner of 1,160,078 shares of Common Stock, constituting 7.2% of the issued and outstanding shares of Common Stock. As sole stockholders, directors and executive officers of West Creek Capital, Inc., a Delaware corporation that is the general partner of West Creek Capital, L.P., a Delaware limited partnership that is the investment adviser to (i) West Creek Partners Fund L.P., a Delaware limited partnership ("Partners Fund"), (ii) Cumberland Investment Partners, L.L.C., a Delaware limited liability company ("Cumberland"), and (iii) certain private accounts (the "Accounts"), Mr. Feldman and Mr. Hanerfeld may be deemed to have the shared power to direct the voting and disposition of the 723,911 shares of Common Stock owned by Partners Fund, the 360,476 shares of Common Stock owned by Cumberland, and the 75,691 shares of Common Stock held in the Accounts.
