- (1) These shares were withheld by the Company to pay a portion of Mr. Schiller's tax obligation on the vesting of 8,000 shares under the 1997 Capital Appreciation Plan.
- (2) The Options granted to Mr. Schiller vest 20% immediately and at a rate of 20% each anniversary thereafter until fully vested. They expire 5 years after the date of grant.
- (3) These options vest at a rate of 25% on the first anniversary of the date of grant and the remainder vesting on subsequent anniversaries.
