(1) The option grant was approved by the board of directors of Nature's Sunshine Products, Inc. (the "Company") on March 1, 2012, subject to shareholder approval of the stock option plan under which the option was granted. The Company's shareholders approved the plan on August 1, 2012. The option grant includes an additional 8,750 shares which will vest, if at all, upon achievement of certain performance conditions.

(2) Vests as follows: 25% on March 1, 2013; 25% on March 1, 2014; 25% on March 1, 2015; and 25% on March 1, 2016.
