ITEM 5.02 DEPARTURE OF DIRECTORS OR PRINCIPAL OFFICERS; ELECTION OF DIRECTORS; APPOINTMENT OF PRINCIPAL OFFICERS.

Effective May 10, 2006, the board of directors of Glowpoint, Inc. (“Glowpoint”) appointed Peter Rust, 52, to serve on the board of directors and the audit committee. Mr. Rust's term will expire at the annual meeting of stockholders in 2006. Mr. Rust will be compensated in accordance with Glowpoint’s director compensation plan. Since leaving Con Edison Communications, Mr. Rust has consulted for a number of telecommunications, technology, and financial firms.

James Spanfeller, a director of Glowpoint since 2004, resigned from Glowpoint’s board of directors and all committees effective May 10, 2006 as described in the press release filed as Exhibit 99.1 hereto.
