(the "Company") on (1) June 13, 2008, but subject to shareholder approval of an increase in the number of shares available for grant under the Company's 2006 Incentive Compensation Plan. Such shareholder approval was obtained at the Annual Meeting of Stockholders held on May 5, 2009.

(2) The option vests and becomes exercisable in four equal annual installments beginning on June 16, 2010, subject to earlier vesting in full in limited circumstances specified in the award agreement.
